## AIRE Advisors, LLC Form CRS – Client Relationship Summary

#### Introduction

Our firm, AIRE Advisors, LLC, is an investment adviser registered with the Securities and Exchange Commission. We feel that it is important for you to understand how advisory and brokerage services and fees differ to determine which type of account is right for you. There are free and simple tools available to research firms and financial professionals at <a href="http://www.investor.gov/CRS">www.investor.gov/CRS</a>, which also provides educational materials about investment advisers, broker-dealers, and investing.

## What investment services and advice can you provide me?

We are a registered investment adviser that offers investment advisory services, including Comprehensive Portfolio Management, AIRE ONE Comprehensive Wealth Management, Cash Management, Financial Planning & Consulting, and Financial Institution Consulting Services to clients. If you open an advisory account with our firm, we'll meet with you to understand your current financial situation, existing resources, objectives, and risk tolerance. Based on what we learn, we'll recommend a portfolio of investments that is monitored at least annually, and if necessary, rebalanced to meet your changing needs and goals. We'll offer you advice on a regular basis and contact you at least annually to discuss your portfolio.

We manage accounts on a discretionary basis. After you sign an agreement with our firm, we're allowed to buy and sell investments in your account without asking you in advance. Any limitations will be described in the signed advisory agreement. We will have discretion until the advisory agreement is terminated by you or our firm.

We do not restrict our advice to limited types of products or investments.

Our firm generally requires a minimum household account balance of \$500,000 to open and maintain an account for our Comprehensive Portfolio Management service. Additionally, we generally require a minimum household account balance of \$3,000,000 to open and maintain an account for our Cash Management service. Finally, we generally require a minimum household account balance of \$25,000,000 to open and maintain an account for our AIRE ONE Comprehensive Wealth Management service. These minimum requirements may be waived at our firm's sole discretion.

Financial Planning & Consulting is included in our Comprehensive Portfolio Management and AIRE ONE Comprehensive Wealth Management service for no additional fee. Financial Planning & Consulting is also offered as a separate service for a flat or hourly fee. We do not monitor your investments for the Financial Planning & Consulting service.

#### What fees will I pay?

You will be charged an ongoing monthly fee based on the value of the assets in your account. Our maximum Comprehensive Portfolio Management annual fee is for international clients is 1.50%, while our maximum annual fee for this service for domestic clients is 1.20%. Our firm may charge an annual flat fee for this service that will not exceed the equivalent of the maximum annual fee of 1.50% or 1.20% for our Comprehensive Portfolio Management Service. The maximum fee for our AIRE ONE Comprehensive Wealth Management service is 1.20% and will always be charged as a flat fee. Our maximum Cash Management annual fee is 0.23%. The more assets you have in your advisory account, the more you will pay us. We therefore have an incentive to increase the assets in your advisory account to increase our fees. Our fees vary and are negotiable. The amount you pay will depend, for example, on the services you receive and the amount of assets in your account. Our firm's fees will be automatically deducted from your advisory account, which will reduce the value of your advisory account. Our firm does not offer direct invoicing.

Our maximum flat fee is \$120,000 and/or Our maximum hourly rate is \$800 for our Financial Planning & Consulting service. The fee-paying arrangements will be determined on a case-by-case basis and will be detailed in the signed consulting agreement.

The broker-dealer that holds your assets charges you a transaction fee when we buy or sell an investment for you. The brokerdealer's transaction fees are in addition to our firm's fees for our Comprehensive Portfolio Management, AIRE ONE Comprehensive Wealth Management and Cash Management service.

You may also pay charges imposed by the broker-dealer holding your accounts for certain investments and maintaining your account. Some investments, such as mutual funds, index funds, and exchange traded funds, charge additional fees that will reduce the value of your investments over time.

In certain cases, we may select third party money managers, sub-advisers, and/or separate account managers to assist us with managing your account. If selected, they will charge you a fee, which will be described to you in their Form ADV Part 2A and/or agreement.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

Our firm's financial professionals include licensed insurance agents who sell insurance products for a commission. They have an incentive to recommend insurance products to you to increase their compensation.
